

## **CBA Annual General Meeting**

#### Confirmation of Proxy Voting for the Council for British Archaeology's AGM

Members of the CBA may appoint a proxy vote should if they are not to attend in person the Annual General Meeting to be held on 21<sup>st</sup> February 2026.

- A member may appoint CBA's Chair of Trustees or a proxy of their own choice.
- The name of the proxy or the words CBA Chair should be added to the proxy form.
- If the appointer is an organisational member this form must be under the hand of an officer duly authorised in that behalf.
- In accordance with article 27 of the CBA's Articles of Association individual members have one vote at the AGM. Organisations have a range of votes depending on their size and type as follows:

Organisational membership Size and Type	Number of Votes
Organisational membership up to 200 or organisational members	3 Votes
with no membership with no membership	
Organisational membership between 201 and 500 (inclusive)	5 Votes
Organisational membership over 500	7 Votes

- Organisational members must state the type and size of their organisations on the proxy form.
- A full list of the resolutions being put to the Annual General meeting are provided below for members to indicate how their proxy should vote.
- If this form is returned without any indication as to how the person appointed proxy shall vote, he/she will exercise their discretion as to how to vote or whether to abstain from voting.
- A full list of resolutions is provided with this proxy form.
- The proxy voter should make themselves known at the AGM to CBA Staff.
